Dark is the absence of light. We cannot see anything in complete darkness. Some objects, for example, the sun, light bulbs and candles are sources of light. Objects are easier to see if there is more light. Some surfaces reflect light. Objects are easier to see when there is less light if they are reflective. The light from the sun can damage our eyes and therefore we should not look directly at the sun and can protect our eyes by wearing sunglasses or sunhats in bright light. Shadows are formed on a surface when an opaque or translucent object is between a light source and the surface and blocks some of the light. The size of the shadow depends on the position of the source, object and surface.		Possible evidence - Can describe how we see objects in light and can describe dark as the absence of light - Can state that it is dangerous to view the sun directly and state precautions used to view the sun, for example in eclipses - Can define transparent, translucent and opaque - Can describe how shadows are formed

When an object moves on a surface, the texture of the surface and the object affect how it moves. It may help the object to move better or it may hinder its movement e.g. ice skater compared to walking on ice in normal shoes. A magnet attracts magnetic material. Iron and nickel and other materials containing these, e.g. stainless steel, are magnetic. The strongest parts of a magnet are the poles. Magnets have two poles – a north pole and a south pole. If two like poles, e.g. two north poles, are brought together they will push away from each other – repel. If two unlike poles, e.g. a north and south, are brought together they will pull together – attract. For some forces to act, there must be contact e.g. a hand opening a door, the wind pushing the trees. Some forces can act at a distance e.g. magnetism. The magnet does not need to touch the object that it attracts.		Possible evidence - Can give examples of forces in everyday life - Can give examples of objects moving differently on different surfaces - Can name a range of types of magnets and show how the poles attract and repel - Can draw diagrams using arrows to show the attraction and repulsion between the poles of magnets	
		Application of Key Skills - Carry out investigations to explore how objects move on different surfaces e.g. spinning tops/coins, rolling balls/cars, clockwork toys, soles of shoes etc. - Explore what materials are attracted to a magnet. - Classify materials according to whether they are magnetic. - Explore the way that magnets behave in relation to each other. - Use a marked magnet to find the unmarked poles on other types of magnets. - Explore how magnets work at a distance e.g. through the table, in water, jumping paper clips up off the table. - Devise an investigation to test the strength of magnets.		Possible evidence - Can use their results to describe how objects move on different surfaces - Can use their results to make predictions for further tests e.g. it will spin for longer on this surface than that, but not as long as it spun on that surface - Can use classification evidence to identify that some metals, but not all, are magnetic - Through their exploration, they can show how like poles repel and unlike poles attract, and name unmarked poles - Can use test data to rank magnets

	Many plants, but not all, have roots, stems/trunks, leaves and flowers/blossom. The roots absorb water and nutrients from the soil and anchor the plant in place. The stem transports water and nutrients/minerals around the plant and holds the leaves and flowers up in the air to enhance photosynthesis, pollination and seed dispersal. The leaves use sunlight and water to produce the plant's food. Some plants produce flowers which enable the plant to reproduce. Pollen, which is produced by the male part of the flower, is transferred to the female part of other flowers (pollination). This forms seeds, sometimes contained in berries or fruits which are then dispersed in different ways. Different plants require different conditions for germination and growth.		- Can explain the function of the parts of a flowering plant - Can describe the life cycle of flowering plants, including pollination, seed formation, seed dispersal, and germination - Can give different methods of pollination and seed dispersal, including examples

Key Knowledge Rock is a naturally occurring material. There are different types of rock e.g. sandstone, limestone, slate etc. which have different properties. Rocks can be hard or soft. They have different sizes of grain or crystal. They may absorb water. Rocks can be different shapes and sizes (stones, pebbles, boulders). Soils are made up of pieces of ground down rock which may be mixed with plant and animal material (organic matter). The type of rock, size of rock pieces and the amount of organic matter affect the property of the soil. Some rocks contain fossils. Fossils were formed millions of years ago. When plants and animals died, they fell to the seabed. They became covered and squashed by other material. Over time the dissolving animal and plant matter is replaced by minerals from the water. Key Knowledge Living things can be grouped (classified) in different ways according to their features. Classification keys can be used to identify and name living things. Living things live in a habitat which provides an environment to which they are suited (Year 2 learning). These environments may change naturally e.g. through flooding, fire, earthquakes etc. Humans also cause the environment to change. This can be in a good way (i.e. positive human impact, such as setting up nature reserves) or in a bad way (i.e. negative human impact, such as littering). These environments also change with the seasons; different living things can be found in a habitat at different times of the year.		Possible evidence - Can name living things living in a range of habitats, giving the key features that helped them to identify them - Can give examples of how an environment may change both naturally and due to human impact
